My name is Jennifer Yocum and I have been a resident of Palatine since 1997. I have been riding at Palatine Stables for over 25 years and a border for 20. I am devastated and angry at the abrupt decision to close Palatine Stables. We were given no warning that this was up for a decision and there was zero transparency. Two people—Ben and Josh—who have been in their positions for less than six months never met with the borders or indicated that this was a possibility.

I dont know if you realize just how valuable Palatine Stables have been to the community. Not only do we have riding lessons, we have horse and pony camp. We have pony rides and pony parties. We have NWSRA use our facility for special needs youth. We have had at risk children from the inner city come out to bond with the horses. Girl Scouts and Boy Scouts have used our facility to earn their badges. We recently hosted several IEA shows—the equivalent of middle school and high school teams like soccer or other team sports.

The effect horses have on both children and adults has been proven time and time again. They help with anxiety and depression. They help teach responsibility and confidence. Children that rode at Palatine Stables have gone on to equestrian colleges and now work in the equestrian field.

I can not even begin to share with you the amount of parents and people that have told me the impact horses have had on their children and their mental health. The amount of parents that said their children would not be alive without Palatine Stables and riding the horses. We hear how the kids are completely different at the barn then they are at school—it opens them up and allows them to feel like they can be themselves. Children and adults alike have said how being with the horses help with their migraines and ADHD. We have had many students that have struggled with their sexual identity and felt safe at Palatine Stables. Already, the mom of the little girl that rides my horse said she is having nightmares because of this decision. Parents have reached out to therapist and crisis intervention specialists on how to break the news to their children that the barn is closing.

On a personal level, I can 100% assure that the only realize I am still alive is because of the barn. I lost my only living family member-my mother-to dementia last year. My mother lived four hours away from me and the stress and sadness was overwhelming. I had no one to turn to except my barn family and my horse. They kept me sane and alive. This place has been so important to my mental health. To think that all of this would just be carelessly thrown away is beyond compression.

I am embarrassed as a resident of Palatine how it was presented to the board that the only option was to close the barn. We have always asked for repairs and nothing would be done. We have seen the report that this decision was based on and it is apparent it doesn't match what the park district told us. We recently had a hay barn added on to one of our barns. First off you are just going to throw that money away (if you close the barn) and secondly I highly doubt any contractor would have agreed to build on that addition if the barn was really that unsafe.

I have talked to so many residents of Palatine and when I tell them we think they are going to put soccer fields where the barn is the response is always the same—we dont NEED more soccer fields. We have had such an outreach of support from not only Palatine but also surrounding communities since our barn is one of the few in the area to offer as much as we do. I bought my condo in Palatine specifically because of the proximity to the barn. I dont think I could stand to live in Palatine if the barn is allowed to be destroyed.

I am writing to you to voice my opposition and concern over the potential closure of operations at Palatine Stables. Palatine Stables and its horses are part of the heritage of the Village of Palatine, and its programs make a unique and positive impact upon the lives of thousands in our community. The programs run here are rare, as riding is becoming less accessible. Palatine is held in such high regard in the horse world for offering such amazing and accessible programming to the community and even those outside of it.

The amount of enrichment, connection and learning that comes from the equestrian programs at the stables is unparalleled and hastily shuttering the operations would be a devastating loss.

Palatine Stables is an icon in the community, in that the program and the horses allow for all types of families, of all socio-economic means, the ability to experience the joys of riding, the discipline, hard work, empathy and care it takes to care for and learn from an animal. In a sport that is becoming more and more privatized (and therefore less and less accessible to our community members and beyond), the program at Palatine Stables is spoken of with reverence and respect. It's a highlight to the Park District and something people speak so positively in regards to the town.

It's concerning that such a significant decision was made without adequate public input or information, when with there might be other solutions and end results. The reasoning shared with the public is the facility's condition and repair costs, but in light of the District's overall budget and its investments in other facilities the decision doesn't make sense to the majority of community members. The users of Palatine Stables are as important to the community as those involved in other programs like soccer, football, and swimming.

Moreover, the decision seems to have been based on just one cost estimate for repairs, which raises questions about the completeness and haste of the process. This matter is too significant to be decided without proper information.

In addition, such a sudden and hasty closure puts at risk the many, many horses that are part of this program. Unlike old sports uniforms you can donate or give to goodwill, these horses are animals with established lives and routines that are important. As "school horses" whose have a very specific job - to safely and competently help kids of all ages learn to ride - their future is based on being able to be placed or sold into a similar program. Given the rarity of schooling programs, that is a process would need to be approached with care and takes time, otherwise the risk to the lives of these animal is dire.

I strongly encourage The Park District to reconsider the future of Palatine Stables and thoroughly explore all alternatives to closure. This reassessment should be done in a

transparent manner that involves the community to ensure that all avenues have been explored and a decision isn't arrived at in haste or with incomplete information.
